ANNUAL REPORT Department of Epidemiology 1957 - 1958

SECTION I. ORGANIZATION

The Department of Epidemiology consists of two professors, the Dean of the School of Public Health acting as Department Head of Epidemiology, and a Director of Chronic Disease, and one secretary. There are five unfilled positions (four faculty and one secretary) which will be filled by September, 1958.

SECTION II. BUDGETS AND GRANTS

The Chronic Disease Division operates under training grants from the National Institutes of Health.

The Department of Epidemiology has \$13,000 State funds, a \$25,000 Epidemiology Training Grant from U.S.P.H.S., and a \$10,000 Epidemiology Training Grant from U.S.P.H.S.- N.I.H.

SECTION III. PHYSICAL FACILITIES

There has been no change in physical facilities since last year. We share with the rest of the departments the overcrowded conditions of work and the need for more adequate quarters for present personnel. Research grants which would be available are out of the question until more physical facilities are provided. The immediate urgent need is for office space for four more faculty and one secretary who will be here between July 1 and September of this year.

SECTION IV. INSTRUCTIONAL ACTIVITIES

The teaching loads have remained heavy this year. We have continued to participate in P.H. 102 and P.H. 103, with increased emphasis upon chronic diseases. We have participated actively in P.H. 105, Health and Sickness in Modern Society, P.H. 185, Mental Health, P.H. 202, Tuberculosis Control Methods, P.H. 204 The Control of Acute Communicable Disease, P.H. 305c, Seminar in Public Health Administration, and conducted a section in P.H. 305b, Evaluation of Community Health. In general, lecture and seminar sessions have been conducted in the above courses, also in short courses, workshops, institutes, and at North Carolina College, Duke Medical School, Duke School of Hospital Administration, Bowman Gray Medical School, the University of North Carolina Medical School, and the University of North Carolina Dental School.

SECTION V. ACTIVITIES IN THE UNIVERSITY

Dr. McGavran has continued to function as a member of the Board of Governors of the Institute for Research in Social Science, and with the Registration Committee in addition to the usual functions of the Dean pertaining to the School of Public Health and the Division of Health Affairs.

Dr. Cassel, of the Chronic Disease Section, was an Assistant Clinical Professor in the Department of Medicine. In addition, Dr. Cassel was Faculty Council Representative for the Division of Health Affairs and served as a member on the Committee on Patient Services.
