### III. PHYSICAL FACILITIES

#### IV. INSTRUCTIONAL ACTIVITIES

During the current year there have been sixteen students majoring in the field of Epidemiology. Four of these students will complete the requirements for the degree of Master of Public Health by August 1964. One has completed course requirements for the degree of Doctor of Public Health and is working on his dissertation. One has completed course requirements for the degree of Ph.D. and is working on his dissertation. One student will spend an additional year working toward his Doctor of Public Health and six toward their Ph.D. We have one student who has finished the M.P.H. requirements and has been taking the advanced Epidemiology courses, and one special student who did not get the M.P.H., but who has taken advanced Epidemiology training. One student will spend an additional year working on the M.P.H. Two students are working for Ph.D.'s in Sociology and respectively are taking Epidemiology as their minor.
