III. PHYSICAL FACILITIES

The Department of Epidemiology is located on the second floor of the North Wing of the New School of Public Health Building. There are eight offices occupied by professors, three by research associates, and one large office used by the doctoral students. In addition, there is a conference room, an IBM machine room with office space for the machine room supervisor and one large office occupied by the three secretaries.

The electronic data processing equipment belonging to the Department includes: IBM 101, 026, 083, 085, and 514.

Two small microbiology laboratories, located on the first floor of the South Wing, have been furnished and are now being used by Department personnel. A third laboratory in the North Wing, second floor, has been remodelled for Department use and is functioning now.

IV. INSTRUCTIONAL ACTIVITIES

During the current year there have been nineteen students majoring in the field of Epidemiology. Five of these students will complete the requirements for the degree of Master of Public Health by August 1966. Two have completed course requirements for the degree of Ph.D. and are working on dissertations. Nine students will spend an additional year working toward their Ph.D. or Dr. P.H. We have three students who will spend an additional year for the M.P.H.

B. Course Teaching Outside the Department

Courses taught in other departments and schools of the University which have been set up for them:

- Dental School Dr. John T. Fulton helps teach the course in Preventive Dentistry 112, to 50 students.

 He also helps teach Preventive Dentistry 136, to 50 students. He teaches for a total of 8 hours instruction.
- Medical School- Dr. John Cassel lectured for 1 hour to 60 students in the Epidemiology course for 2nd year medical students.
 - Dr. H. A. Tyroler lectured for 1 hour to 60 students in the Epidemiology course for 2nd year medical students.

Anthropology - Dr. Ralph Patrick is responsible for teaching General Anthropology to 100 students (3 hrs. credit) 45 hours of instruction.

Sociology - Dr. Robert Wilson is responsible for teaching Literature and Society in the Department of Sociology. 55 students (3 hrs. credit) 45 hours of instruction.

Nutrition - Dr. Ralph Patrick teaches Nutrition 240 - Family Dietary Practices and Their Determinants, with Miss Broach. 4 students (2 hrs. credit) approximately 15 hours of instruction.

School of Nursing - Dr. Ralph Patrick gave lectures for 2 hours to approximately 60 students in the School of Nursing.

Pathology - Dr. Gordon Stewart teaches undergraduate students, participates in infectious disease consultative service, attends rounds and gives a seminar to residents and interns on Infectious Disease under the terms of his joint appointment.

Pathology - Dr. Stewart helps teach Immuno Pathology - 161A to 118 students for approximately 22 hours of instruction.

Administration - Dr. Robert Wilson helps teach HADM 250 to 15 students. 15 hours of instruction.

Pharmacy - Dr. H. A. Tyroler gave a lecture to the 5th year class on Principles of Public Health.
75 students. 1 hour of instruction.

Teaching at other Universities in courses set up for the students at those Universities:

Duke University - School of Nursing - Dr. Cecil Slome teaches a public health course entitled Public Health Sciences which is devoted to Epidemiology.

There are 50 students and he gives 12 hours of instruction.

Tyroler gave 6 two hour lectures to the sophomore medical students on introductory epidemiology. There were 65 - 70 students.

Instruction given to students from other departments and schools in this University enrolled in regular public health courses in the School of Public Health.

Anthropology - Dr. Ralph Patrick teaches 4 students from Anthropology who are minoring in epidemiology. They are enrolled in Epid. 140 and he gives instruction for approximately 30 hours each.

Sociology - Dr. Robert Wilson teaches 2 sociology students enrolled in Epid. 140 for a total of 25 hours.

Medical School - During the summer Dr. H. A. Tyroler teaches 5 medical students for 30 hours each.

Dental School - There were 2 dental students enrolled in Epid. 160. (3 credit hours) 45 hours instruction.

N.C. State - There were 2 statistical students enrolled in Epid. 160 for 3 credit hours (45 hours instr.)

In addition to the above listed courses, the faculty of the Department of Epidemiology give a number of single lectures in courses taught by other departments in the School of Public Health. A few of these are listed below:

HADM 100 - Dr. Ralph Patrick lectured for 2 hours in the course. There were 125 students enrolled.

XI. NEEDS AND DIRECTION OF DEVELOPMENT OF THE DEPARTMENT

The recent growth of the Department has been a result in part of the development of ideas generated by a very active faculty and increasing body of advanced students and in part a response to the increasing demands of the Department by other units within the School of Public Health, the Medical School, other Universities, state and local Health Departments, the Public Health Service and the World Health Organization.

Meeting even a small proportion of these demands has necessitated increasing the size of the faculty and has led to an aggravation of the problem of space. The space problem has been compounded by the development of a laboratory and infectious disease unit in the Department (two badly needed developments to round out our programs) and by the demands of the Population Program and pending developments in International Health.

The major direction, as far as future faculty are concerned, will be to recruit junior personnel who can assist the existing senior faculty members and who will form a readily mobile cadre capable of assisting developments in various countries in the International Health Program.
